**REQUESTED ACTION**

Pursuant to the provisions of RSA 14:30-a, VI, authorize the Department of information Technology (DoIT) to amend an American Rescue Plan Act (ARPA) State Fiscal Recovery Funds (SFRF) item approved by Fiscal Committee on September 13, 2024 item FIS 24-314 and by Governor and Executive Council on September 25, 2024 Item #58 by reallocating \$365,700 in and among classes within an accounting unit for the purposes of migrating the Office of Professional Licensure and Certification (OPLC) legacy system to the Salesforce Public Sector Solution licensing environment, effective upon Fiscal Committee and Governor and Executive Council approval through June 30, 2025. The original item was approved by Fiscal Committee on July 22, 2022 item FIS 22-265 and approved by Governor and Executive Council on July 27, 2022 item #29, extended by the Fiscal Committee on May 19, 2023 item FIS 23-166 and by Governor and Executive Council on May 31, 2023 item #160, extended again by the Fiscal Committee on May 17, 2024 item FIS 24- 182 and by Governor and Executive Council on May 15, 2024 item #154. This is an allowable use of ARPA SFRF funds under Sections 602(c)(1)(A) to response to the public health emergency or its negative economic impacts.100% Federal Funds.

**EXPLANATION**

OPLC is the state agency charged with providing administrative support to most of the state's professional licensing boards, including all the state's health licensing boards. OPLC also directly regulates four professions and issues 184 unique permanent licenses, certifications, permits, and registrations. 157,075 permanent licenses are subject to renewal requirements, typically on a biennial basis. Approximately 40,000 additional registrations, apprentice licenses, certifications, and endorsements are currently active within the Office. In total, OPLC authorizes nearly 200,000 individuals to work within the State - an amount equal to 15% of the State's population. Efficient OPLC operations are crucial to reducing barriers to workforce entry in New Hampshire.

OPLC is the process of migrating the Office of Professional Licensure and Certification legacy system to the Salesforce Public Sector Solution licensing environment. The new licensing online portals will greatly improve the customer experience, as well as agency productivity and efficiency. The online portals allow licensees, licensed businesses, and the public direct access to OPLC services.

The Department of Information Technology requests authorization to transfer account funds among the classes to continue to meet the Office of Professional Licensure and Certification requirements.

Funds are to be budgeted as follows:

**Class 038-Technology Software:** Decrease \$365,700

Actual project costs require less funding for software than was originally estimated at the time the ARPA grant request was submitted for approval.

**Class 046-Consultants:** Increase \$365,700

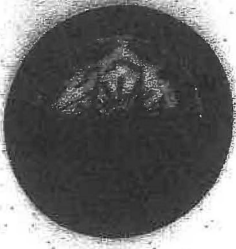

**REQUESTED ACTION**

Pursuant to the provisions of RSA 14:30-a, VI, authorize the Department of Information Technology (DoIT) to amend FIS 24-208 approved by the Fiscal Committee on June 20, 2024 and by the Governor and Executive Council item #76 on June 26, 2024 to accept and expend an additional \$1,500,000 of American Rescue Plan Act (ARPA) State Fiscal Recovery Funds (SFRF) to continue the modernization of the State of NH Licensing Portal, effective upon approval by the Fiscal Committee and Governor and Executive Council through June 30, 2025. The original item was approved by the Fiscal Committee on July 22, 2022 item FIS 22-265 and approved by Governor and Executive Council on July 27, 2022 item #29, extended by the Fiscal Committee on May 19, 2023 item FIS 23-166 and by Governor and Executive Council on May 31, 2023 item #160, and extended again by the Fiscal Committee on May 17, 2024 item FIS 24-182 and by Governor and Executive Council on May 15, 2024 item #154. This is an allowable use of ARPA SFRF funds under Sections 602(c)(1)(A) to response to the public health emergency or its negative economic impacts. 100% Federal Funds.

Funds are to be budgeted in FY2025 in 01-03-003-030010-26630000<sup>1</sup> DoIT ARP Licensing Portal.

#### EXPLANATION

These funds would continue the program (described below) that was initiated on July 17, 2022, when the Fiscal Committee approved an initial allocation of \$3,944,440 of ARPA funds for this project. This additional funding would enable the agency to accelerate the implementation of additional license types on the Salesforce platform and would benefit OPLC and DoIT staff by adding more time to gain familiarity with the platform prior to having to support it without the consulting help.

The significant shortage of healthcare workers in New Hampshire is at crisis levels. To adequately address this shortage, meaningful policy decisions require access to current and reliable data. OPLC, as licensor to nearly all of the State's healthcare workforce, requires access to this data, but data availability via the current licensing portal is extremely limited.

Office of Professional Licensure & Certification (OPLC) is the state agency charged with providing administrative support to most of the state's professional licensing boards, including all the state's health licensing boards. OPLC also directly regulates four professions. OPLC issues 184 unique permanent licenses, certifications, permits, and registrations. 157,075 permanent licenses are subject to renewal requirements, typically on a biennial basis. Approximately 40,000 additional registrations, apprentice licenses, certifications, and endorsements are currently active within the Office. In total, OPLC authorizes nearly 200,000 individuals to work within the State—an amount equal to 15% of the State's population. Efficient OPLC operations are crucial to reducing barriers to workforce entry in New Hampshire.

The solution to this backlog and the resultant increase in effective service delivery is to implement a new more effective licensing system. The new system will help in three ways: 1) cause a near elimination of incomplete applications being submitted, 2) cause a significant reduction in call volume and improved customer service, and 3) improve data analytics concerning workforce. Our goal is to select a solution that will not only be the most cost-effective option for the state, but one that also provides a very fast time to value, especially for

the critical Online Services function. Work on the system will continue to be prioritized to target those sectors that will have the largest positive impacts on effective service delivery first.

A new licensing system will give OPLC the ability to generate up to date, accurate reports used to directly address the needs of the State. Implementation of the new system is a critical step in allowing OPLC to work with agency partners in responding to and making policy decisions around workforce changes and shortages in strategic and impactful ways.

The additional \$1.5M will be used to assist in the configuration and migration of numerous boards by hiring additional consultants. These consultants will assist DoIT and OPLC personnel in the transition from the legacy application to the Salesforce platform. As the project progressed, it became evident that the level of complexity in getting the platform ready to support the myriad license types in a standard constituent friendly manner warranted additional resources in order for the project to move forward in a timely and long term supportable manner.

#### 1. Online Services

The new solution will provide the ability for users to securely log in and perform online transactions based on the agency's business policies and rules. This application provides a highly dynamic, mobile-ready, and intuitive interface for applicants completing online initial applications and renewal requirements. **Current Status:** The Salesforce platform is entirely built out to support online services, and we are ready to go live with the Real Estate board. The lion's share of the effort was in getting the platform ready. We expect the additional license types to be much quicker and easier to implement based on this foundational work.

#### 2. Case Management and Inspection

The platform includes a focused experience for Investigators that are working case assignments to build an Investigative Report for review. The module also includes an online submission feature that allows the Complainant the ability to submit the complaint online to the Agency and receive ongoing status updates.

A field-based inspection solution that extends the platform to field inspectors and other State personnel is also included, which allows the application to be used offline through various mobile devices for a variety of inspection tasks while in the field. **Current Status:** Work on this will begin in parallel with the upcoming roll out of new online services and backoffice license management capabilities.

#### 3. BackOffice License Management

Provides robust capabilities to process applications, automate license renewals, and generate timely communications to stakeholders. **Current Status:** The Salesforce platform is entirely built out to support backoffice license management. Pending final testing and approval of the payment card interface we are ready to go live with the Real Estate board. The lion's share of the effort was in getting the platform and the payment card processing ready. We expect the additional license types to be much quicker and

easier to implement based on this foundational work. We plan on implementing features for online services and backoffice license management at the same time for all license types going forward.

The Department of Information Technology respectfully requests additional ARPA funding in the amount of \$1,500,000. Should this be approved we are ready to quickly encumber this and the remaining unencumbered balances from the initial appropriation under an existing statewide contract (Salesforce Master Services Agreement).

Funds are to be budgeted as follows:

**Class 041 - Audit Fund Set Aside:** to comply with RSA 124: 16 that requires all agencies that receive federal funds to set aside a percentage (0.1 %) of the federal revenue amount received to pay for financial and compliance audits.

**Class 046 - Consultants**

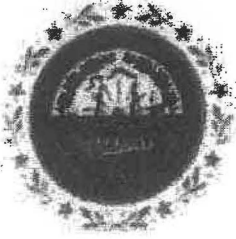

### REQUESTED ACTION

Pursuant to RSA 14:30-a, VI and RSA 124:15, the Department of Administrative Services (DAS) is seeking approval on behalf of State Agencies to amend the accept and expend of American Rescue Plan Act (ARPA) State Fiscal Recovery Funds (SFRF) requests by extending the end date for funding, new positions, and/or new Class 046-Consultants, created in relation to the acceptance of ARPA SFRF funds, from June 30, 2024 to June 30, 2025, effective upon approval of the Fiscal Committee and the Governor and Executive Council. 100% Federal Funds.

### EXPLANATION

The Department of Administrative Services is seeking approval, on behalf of the State Agencies listed in Attachment A, to extend the effective through date from June 30, 2024 to June 30, 2025. All items included in the attachment have been previously submitted by the respective state agency responsible for the program and approved by both the Fiscal Committee and Governor and Executive Council. In addition, the Governor's Office of Emergency Relief and Recovery (GOFERR) has reviewed the attachment and concurs with the extensions requested.

While all ARPA SFRF must be obligated by December 31, 2024, and expended by December 31, 2026, approval of this request will reauthorize funding for projects or programs using ARPA SFRF and authorize agencies' program balances that are unspent as of June 30, 2024, as well as positions and consultants created pursuant to RSA 124:15, to carry forward into Fiscal Year 2025. This request will also grant agencies in coordination with GOFERR time to continue to evaluate projects and programs as the ARPA SFRF obligation deadline approaches in order to ensure any funds that may need to be


reallocated to other uses have sufficient time to do so. Any request to reallocate an existing budget or repurpose funds for new or existing projects will require future Fiscal Committee and Governor and Council approvals and are not contemplated in this item.

If this item is not timely approved, the State would need to issue layoff notices to employees hired into these federally funded positions, created under the original ARPA request; agencies would halt work on time-sensitive projects or payments on existing contracts; and ongoing programs would be unable to issue or follow through on awards. Further, each agency would then need to submit a request for approval to reauthorize the positions and funding; however, the requests potentially would not eliminate the need to issue layoff notices in June 2024 due to layoff notice provisions.

Typically, agencies budget for known federal grants in the biennial budget process; however, the budget guidance issued in August 2022 instructed Agencies to exclude all COVID-related funding from their FY24-FY25 budget submissions in order to maintain the authorization methodology, compliance protocols, and audit trail that had become standard for use and oversight of ARPA SFRF. Moreover, although the funding is authorized by the federal government beyond June 30, 2024, including this one-time funding would have erroneously inflated the FY24-FY25 State budget.

In the event that Federal Funds are no longer available, General Funds will not be requested to support these programs. The Department of Administrative Services seeks approval of this request.

## REQUESTED ACTION

Pursuant to RSA 14:30-a, VI and RSA 124:15, the Department of Administrative Services (DAS) is seeking approval on behalf of State Agencies to amend the accept and expend of American Rescue Plan Act (ARPA) State Fiscal Recovery Funds (SFRF) requests by extending the end date for funding, new positions, and/or new Class 046-Consultants, created in relation to the acceptance of ARPA SFRF funds, from June 30, 2023 to June 30, 2024, effective upon approval of the Fiscal Committee and the Governor and Executive Council. 100% Federal Funds.

## EXPLANATION

The Department of Administrative Services is seeking approval, on behalf of the State Agencies listed in Attachment A, to extend the effective date of the attached items from June 30, 2023 to June 30, 2024. This extension is allowable under the "procedural rules amendment" approved at the previous Fiscal Committee meeting on April 21, 2023. All items included in the attachment have been previously submitted by the respective state agency responsible for the program and approved by both the Fiscal Committee and Governor and Executive Council. In addition, the Governor's Office of Emergency Relief and Recovery (GOFERR) has reviewed the attachment and concurs with the extensions requested.

While all ARPA SFRF must be obligated by December 31, 2024, and expended by December 31, 2026, this request only serves to authorize agencies' program balances that are unspent as of June 30, 2023, as well as positions and consultants created pursuant to RSA 124:15, to carry forward into FY24 and reauthorize projects or programs that were already intended to continue utilizing authorized ARPA SFRF into the next biennium. This will also grant agencies in coordination with GOFERR time to further evaluate projects and programs as the ARPA SFRF obligation deadline approaches in order to

ensure any funds that may need to be reallocated to other uses have sufficient time to do so. Any request to reallocate an existing budget or repurpose funds for new or existing projects will require future Fiscal Committee and Governor and Council approvals and are not contemplated in this item.

If this item is not timely approved, the State would need to issue layoff notices to employees hired into these federally funded positions, created under the original ARPA request, agencies would halt work on time-sensitive projects or payments on existing contracts, and ongoing programs would be unable to issue or follow through on awards. Further, each agency would then need to submit a retroactive request to July 1, 2023 for approval to reauthorize the positions and funding; however, the retroactive requests would not eliminate the need to issue layoff notices in June 2023.

Typically, agencies budget for known federal grants in the upcoming biennial budget; however, the budget guidance issued in August 2022 instructed Agencies to exclude all COVID-related funding from their FY24-FY25 budget submissions in order to maintain the authorization methodology, compliance protocols, and audit trail that had become standard for use and oversight of ARPA SFRF. Moreover, although the funding is authorized by the federal government beyond June 30, 2023, including this one-time funding would have erroneously inflated the FY24-FY25 State budget.

In the event that Federal Funds are no longer available, General Funds will not be requested to support these programs. The Department of Administrative Services seeks approval of this request.

### EXPLANATION

The significant shortage of healthcare workers in New Hampshire is at crisis levels. To adequately address this shortage, meaningful policy decisions require access to current and reliable data. OPLC, as licensor to nearly all the State's healthcare workforce, requires access to this data, but data availability via the current licensing portal is extremely limited.

Office of Professional Licensure & Certification (OPLC) is the state agency charged with providing administrative support to most of the state's professional licensing boards, including all the state's health licensing boards. OPLC also directly regulates four professions. OPLC issues 184 unique permanent licenses, certifications, permits, and registrations. 157,075 permanent licenses are subject to renewal requirements, typically on a biennial basis. Approximately 40,000 additional registrations, apprentice licenses, certifications, and endorsements are currently active within the Office. In total, OPLC authorizes nearly 200,000 individuals to work within the State—an amount equal to 15% of the State's population. Efficient OPLC operations are crucial to reducing barriers to workforce entry in New Hampshire.

When the COVID-19 pandemic began, healthcare providers across the nation quickly moved to a telehealth platform to prevent and limit the spread of the virus. This posed two unique challenges for New Hampshire: 1) as the practice of healthcare is deemed to occur where the patient is physically located, providers who typically provided care for New Hampshire patients in border states (such as Vermont and Massachusetts) suddenly needed a New Hampshire license to continue to legally provide services to those patients, and to receive reimbursement from insurance providers for such services, and 2) healthcare facilities are relying on traveling healthcare workers to meet immediate workforce needs with increasing frequency. An expedited licensing process is critical to ensure continuity of care for New Hampshire patients. OPLC was/is inundated with applications and requests for prompt licensure due to COVID-19. The backlog created by this surge in requests is disrupting effective service delivery in many sectors including some of our most critical areas like nursing.

The solution to this backlog and the resultant increase in effective service delivery is to implement a new more effective licensing system. The new system would help in three ways: 1) cause a near elimination of incomplete applications being submitted, 2) cause a significant reduction in call volume and improved customer service, and 3) improve data analytics concerning workforce. Our goal would be to select a solution that will not only be the most cost effective option for the state, but must also provide a very fast time to value, especially for the critical Online Services function. Work on the system would be prioritized to target those sectors that will have the largest positive impacts on effective service delivery first.

A new licensing system will give OPLC the ability to generate up to date, accurate reports used to directly address the needs of the State. Implementation of the new system is a critical step in allowing OPLC to work with agency partners in responding to and making policy decisions around workforce changes and shortages in strategic and impactful ways.

The project is planned for three phases, with the most important services addressed in phase one, and with end goals that include system modernization, addressing backlogs, and reducing the negative impacts on our workforce generated by the current system.

1. Online Services

The new solution will provide the ability for users to securely log in and perform online transactions based on the agency's business policies and rules. This application provides a highly dynamic, mobile-ready, and intuitive interface for applicants completing online initial applications and renewal requirements.

2. Case Management and Inspection

The platform includes a focused experience for Investigators that are working case assignments to build an Investigative Report for review. The module also includes an online submission feature that allows the Complainant the ability to submit the complaint online to the Agency and receive ongoing status updates.

A field-based inspection solution that extends the platform to field inspectors and other State personnel is also included, which allows the application to be used offline through various mobile devices for a variety of inspection tasks while in the field.

Electronic Business Intelligence (EBI) will be implemented on our standard enterprise platform (currently being used by DHHS Public Health and Department of Education). Analytics generated by this platform will help target investigative and enforcement activities.

3. BackOffice License Management

Provides robust capabilities to process applications, automate license renewals, and generate timely communications to stakeholders.

The Department of Information Technology respectfully requests ARPA funding in the amount of **\$3,944,440**. This amount will cover all three phases of the Licensing Portal Modernization Project.

Funds are to be budgeted as follows:

**Class 038 - Technology, Software:** Procure licenses and technical support for the new Licensing Portal.

**Class 040 - Indirect Expenses:** Budgeted at a rate of 10% of direct costs up to the first \$25K of any contract outsourcing functions or sub awards

### EXPLANATION

This initiative consists of multiple components to address Core IT infrastructure modernization, that will enhance security and monitoring capabilities, allows for rapid infrastructure expansion to address capacity and business needs that have been challenging during COVID, while providing added protection of State and citizen information.

The ability to maintain and refresh DoIT core infrastructure services helps ensure that critical systems and services are available to agencies, citizens and businesses in the event of a crisis, and the systems are current to maintain proper security updates. This includes providing protection-against unexpected events impacting the delivery of DoIT services provided from the primary data center, enhanced security to defend against attacks on the primary data center such as ransomware and other cybersecurity attacks, the prevention of data loss, and the infrastructure required to provide disaster recovery services in the event the State's primary data center services are unavailable.

DoIT was originally awarded a total of \$23,600,000.00 as part of the DoIT ARP Critical IT Infrastructure initiative. This funding is being used to refresh and expand the network infrastructure for all executive branch agencies, along with critical server and data center infrastructure. The transfer reclass funding request will re-align funds to allow for the completion of the network upgrade work and begin replacement of our aged server environment.

DoIT is requesting the transfer of funds between classes to best use the available appropriation, as shown below:

Class 037      Increase Technology Hardware: Technology Hardware is needed to cover additional network infrastructure required to complete the network upgrade program and fund refresh of a portion of the virtual server environment to address end of life equipment.

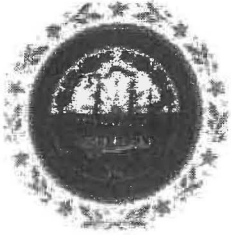

## EXPLANATION

The Department of Administrative Services is seeking approval, on behalf of the State Agencies listed in Attachment A, to extend the effective through date from June 30, 2024 to June 30, 2025. All items included in the attachment have been previously submitted by the respective state agency responsible for the program and approved by both the Fiscal Committee and Governor and Executive Council. In addition, the Governor's Office of Emergency Relief and Recovery (GOFERR) has reviewed the attachment and concurs with the extensions requested.

While all ARPA SFRF must be obligated by December 31, 2024, and expended by December 31, 2026, approval of this request will reauthorize funding for projects or programs using ARPA SFRF and authorize agencies' program balances that are unspent as of June 30, 2024, as well as positions and consultants created pursuant to RSA 124:15, to carry forward into Fiscal Year 2025. This request will also grant agencies in coordination with GOFERR time to continue to evaluate projects and programs as the ARPA SFRF obligation deadline approaches in order to ensure any funds that may need to be

reallocated to other uses have sufficient time to do so. Any request to reallocate an existing budget or repurpose funds for new or existing projects will require future Fiscal Committee and Governor and Council approvals and are not contemplated in this item.

If this item is not timely approved, the State would need to issue layoff notices to employees hired into these federally funded positions, created under the original ARPA request; agencies would halt work on time-sensitive projects or payments on existing contracts; and ongoing programs would be unable to issue or follow through on awards. Further, each agency would then need to submit a request for approval to reauthorize the positions and funding; however, the requests potentially would not eliminate the need to issue layoff notices in June 2024 due to layoff notice provisions.

Typically, agencies budget for known federal grants in the biennial budget process; however, the budget guidance issued in August 2022 instructed Agencies to exclude all COVID-related funding from their FY24-FY25 budget submissions in order to maintain the authorization methodology, compliance protocols, and audit trail that had become standard for use and oversight of ARPA SFRF. Moreover, although the funding is authorized by the federal government beyond June 30, 2024, including this one-time funding would have erroneously inflated the FY24-FY25 State budget.

In the event that Federal Funds are no longer available, General Funds will not be requested to support these programs. The Department of Administrative Services seeks approval of this request.

## REQUESTED ACTION

Pursuant to RSA 14:30-a, VI and RSA 124:15, the Department of Administrative Services (DAS) is seeking approval on behalf of State Agencies to amend the accept and expend of American Rescue Plan Act (ARPA) State Fiscal Recovery Funds (SFRF) requests by extending the end date for funding, new positions, and/or new Class 046-Consultants, created in relation to the acceptance of ARPA SFRF funds, from June 30, 2023 to June 30, 2024, effective upon approval of the Fiscal Committee and the Governor and Executive Council. 100% Federal Funds.

## EXPLANATION

The Department of Administrative Services is seeking approval, on behalf of the State Agencies listed in Attachment A, to extend the effective date of the attached items from June 30, 2023 to June 30, 2024. This extension is allowable under the "procedural rules amendment" approved at the previous Fiscal Committee meeting on April 21, 2023. All items included in the attachment have been previously submitted by the respective state agency responsible for the program and approved by both the Fiscal Committee and Governor and Executive Council. In addition, the Governor's Office of Emergency Relief and Recovery (GOFERR) has reviewed the attachment and concurs with the extensions requested.

While all ARPA SFRF must be obligated by December 31, 2024, and expended by December 31, 2026, this request only serves to authorize agencies' program balances that are unspent as of June 30, 2023, as well as positions and consultants created pursuant to RSA 124:15, to carry forward into FY24 and reauthorize projects or programs that were already intended to continue utilizing authorized ARPA SFRF into the next biennium. This will also grant agencies in coordination with GOFERR time to further evaluate projects and programs as the ARPA SFRF obligation deadline approaches in order to

ensure any funds that may need to be reallocated to other uses have sufficient time to do so. Any request to reallocate an existing budget or repurpose funds for new or existing projects will require future Fiscal Committee and Governor and Council approvals and are not contemplated in this item.

If this item is not timely approved, the State would need to issue layoff notices to employees hired into these federally funded positions, created under the original ARPA request, agencies would halt work on time-sensitive projects or payments on existing contracts, and ongoing programs would be unable to issue or follow through on awards. Further, each agency would then need to submit a retroactive request to July 1, 2023 for approval to reauthorize the positions and funding; however, the retroactive requests would not eliminate the need to issue layoff notices in June 2023.

Typically, agencies budget for known federal grants in the upcoming biennial budget; however, the budget guidance issued in August 2022 instructed Agencies to exclude all COVID-related funding from their FY24-FY25 budget submissions in order to maintain the authorization methodology, compliance protocols, and audit trail that had become standard for use and oversight of ARPA SFRF. Moreover, although the funding is authorized by the federal government beyond June 30, 2023, including this one-time funding would have erroneously inflated the FY24-FY25 State budget.

In the event that Federal Funds are no longer available, General Funds will not be requested to support these programs. The Department of Administrative Services seeks approval of this request.

#### EXPLANATION

Pursuant to US Treasury 31 CFR Part 35, RIN 1505-AC77, the Coronavirus State Fiscal Recovery Fund established under the American Rescue Plan Act, DoIT will use the funds for the following activities:

**ARP Cybersecurity (\$2,086,000):** The COVID-19 public health emergency continues to have a number of negative impacts to the confidentiality, integrity and availability of critical personal and public health information for New Hampshire's citizens and key public health programs that are protected by DoIT's cybersecurity program. These cybersecurity program enhancements are targeted to address these negative impacts by:

- Monitoring and protecting the real-time flow of personal and federally protected health information related to COVID-19 vaccines, vaccination, and public health issues between state systems and cloud-hosted applications.
- Providing positive identity verification and protection from phishing and ransomware attacks by malicious actors who are using the COVID-19 public health emergency as a lure in phishing emails and infected attachments.
- Expanding our cyber threat analysis capabilities to detect and block malicious cyber activity before it can affect systems that store and protect sensitive personal and public data related to the COVID-19 public health emergency.

The ARP funds in support of Cybersecurity will allow the State of New Hampshire to apply the necessary threat intelligence, identity verification and cyber capabilities to monitor and protect the flow of critical COVID-19 related citizen and public health data against malicious cyber actors and is therefore allowable as a COVID-19 related response to the public health emergency.

**ARP Cloud Services Fiscal Recovery Funds (\$3,449,700):** Two major factors are driving DoIT's request to obtain services and tools to design, develop, implement and provide cloud solutions that will enable and modernize digital government services. First, our historical unbundling strategy has put us at a disadvantage when responding to the challenges of the COVID-19 response and recovery activities that are still continuing. This removed our ability to skip releases and unbundle to reduce operational expenses to enable functional capabilities due to COVID-19. Second, our tools vendor Microsoft has switched from a perpetual license model to a bundled subscription model.

The state has begun implementing these tools based on CARES Act funding provided as part of the state's initial COVID-19 response. Funds are needed to continue and expand functionality and continue support and effective management of the environment, which has become a critical and heavily utilized platform for the state throughout the continuing COVID-19 crisis. This effort has allowed agencies to continue to work effectively during the pandemic due to remote work capability needs to serve its citizens and businesses. These collaboration and cloud services solutions provide flexible and scalable platforms that can adapt to changing business needs and allow the state to react quickly when disasters occur. They also minimize the impact on our state's infrastructure and provide flexibility and enhanced functionality as state agencies expand citizen services. As these improvements continue to be needed to respond to the State's IT needs during the COVID-19 public health emergency the continued reliance of the public on remote communications and access to State services, these services and investments are therefore allowable as a COVID-19 related response to the public health emergency.

**ARP Continuity of Operations (\$871,487):** This request will address core Information Technology services required to implement cloud based infrastructure to accommodate DoIT continuity of operation (COOP) and disaster recovery (DR) services. These services will be based on business needs identified during the COVID-19 response and currently being collected and refined under an existing capital appropriation. In essence, this will improve the ability of NH agencies to support its citizens and businesses during emergency conditions that could potentially disrupt critical services, such as COVID-19.

The ability to run DoIT services from a flexible and scalable cloud platform will provide a more dynamic environment when needed to ensure critical systems and services are available to agencies, citizens and businesses in the event of a crisis.

This includes providing protection against unexpected events impacting the delivery of DoIT services provided from the primary data center, enhanced security to defend against attacks on the primary data center such as ransomware and other cybersecurity attacks, the prevention of data loss, and the infrastructure required to provide disaster recovery services in the event the State's primary data center services are unavailable. As these improvements continue to be needed to respond to the State's IT needs resulting from the COVID-19 public health emergency and the continued reliance of the public on remote communications and access to State services, these services and investments are therefore allowable as a COVID-19 related response to the public health emergency.

**ARP Critical IT Infrastructure (\$23,600,000):** This initiative consists of multiple components to address Core IT infrastructure modernization, that will enhance security and monitoring capabilities, allows for rapid infrastructure expansion to address capacity and business needs that have been challenging during COVID, while providing added protection of State and citizen information. These improvements are allowable as government services under Section 602(c)(1)(C).

**Network Continuity:** Replaces all end of life (EOL) core network infrastructure, agency equipment and addresses capacity constraints, security and compliance issues. The Executive Branch network that supports state agencies has a high percentage of network equipment that is either at EOL or will be at EOL shortly. When equipment reaches its End of Life, vendors no longer provide security patches and other updates which create growing security, federal, and Payment Card Industry (PCI) compliance risks. In addition to EOL equipment there is a major technology shift occurring in the networking space called Software Defined Networking (SDN). States are migrating toward SDN to assist with the increasing requirements for performance and security on their networks driven by:

- Accelerated adoption of cloud computing
- Expansion of Internet of Things (IOT)
- Increased remote workforce needs due to COVID-19
- Steep increase in the volume of citizen critical services that travel on our networks, driven by the COVID-19 public health emergency

DoIT has worked with our network equipment vendor to identify the equipment and services required to keep agency networks performant and compliant for the next 5 – 6 years. The proposal provides a significant discount over our standard pricing by acquiring all of the equipment in a large volume single transaction, along with design and training services. Rapid implementation services are included (12,000 hours), allowing the project to be completed within 12-18 months. The network refresh would replace routers, switches, firewalls, and wireless equipment, along with expanding wireless capabilities to additional agencies.

Implementing this solution will also provide the opportunity to shift ownership and funding of agency network infrastructure environments to DoIT, utilizing the existing Telecommunications revolving fund to address new requirements and future refresh needs.

**DoIT DR/COOP:** Accelerates the planned DoIT core infrastructure DR/COOP solution and addresses the need to replace aged infrastructure in our primary Data Center. The American Rescue Plan funding would be used to expand and accelerate the DoIT Disaster Recovery Services Project proposed for FY22/FY23. Key upgrades to our primary data center at 27 Hazen Drive are required to address severe power, cooling and fault tolerance limitations. These upgrades would include the replacement of transformers, HVAC systems, UPS, distribution panels and adding redundant generator backup, to reduce unplanned downtime and allow routine maintenance without operational shutdowns.

Addressing these deficiencies will significantly extend the long term viability of the Hazen Data Center and allow for further consolidation of on campus data centers. Included in the expanded DR/COOP plan are consulting services thereby allowing DoIT to accelerate and complete the project in 2 years while providing an "Infrastructure as a Service" in the cloud for DR Services.

**Backup:** Modernizes the DoIT backup architecture solution and storage environments through consolidation and implementation of new technologies. Performing regular backups is a critical component of any modern organization's resiliency efforts. One critical reason for creating backups is to perform a restore of data to a given point in time, should data loss or corruption occur. During the COVID-19 response over the past year, backup was a critical service, ensuring we could recover whole systems, department shared drives, personal drives, and databases when the need arose, as well as the backup of new, unplanned pandemic data and applications created in support of the State's response to COVID. Without this resiliency, our pandemic response efforts may have been compromised.

DoIT's growing reliance on critical data and the sheer volume of that data is straining our already aging backup infrastructure, especially when we consider it is ultimately a tape-based system. A modern, tapeless architecture, utilizing hybrid Cloud and Disaster Recovery as a Service (DRaaS) technologies, will allow us to scale in support of growing data needs and speed up recovery, especially when we consider our ability to perform a timely restore from ransomware events such as the Colonial Pipeline compromise. In a number of similar attacks, strong backups reduced, or virtually eliminated, ransom payments.

**Storage:** The ability to store and provide fast, reliable access to data is a critical service in support of our citizens. Nowhere was this more apparent than during the COVID-19 pandemic. Comprehensive data analytics utilized during our pandemic response required high performance solid-state storage and consumed enormous space in support of this critical mission.

However, our current storage landscape consists of nine aging storage arrays, four of which are end-of-life and five approaching end-of-life. As our storage arrays reach EOL, maintenance and support are no longer available from the primary vendor. Contracts with third party vendors have been implemented to provide support, putting the environment at an increased risk. In addition, the sheer number of arrays, all of varying sizes and software release levels, has made support difficult and inefficient. A single, modern array will allow us to consolidate the existing arrays, create administrative efficiency and support future, modern workloads with a hybrid Cloud architecture.
